NOTE: Eligible students will be considered for Federal Direct Loan funds for a maximum period of twelve consecutive months of prerequisite enrollment at U-M-Ann Arbor, as long as the student has not previously borrowed Federal Stafford Loan funds to complete prerequisite course work for admission to a degree program at a post-secondary institution. For students enrolled in course work necessary to enter a second undergraduate program, loan eligibility will not exceed \$2,625 for dependent students or \$8,625 for independent students (or dependent students whose parents cannot borrow PLUS). For students enrolled in course work necessary to enter a graduate program, loan eligibility will not exceed \$5,500 for dependent students or \$12,500 for independent students (or dependent students whose parents cannot borrow PLUS).
