- ◆ **This form is to be completed by international students applying for the Child Care Subsidy** who are not citizens or permanent residents of the United States. If you are a citizen or a permanent resident, you must complete the 2009-2010 Free Application for Federal Student Aid (FAFSA), available on the web: [www.fafsa.ed.gov](http://www.fafsa.ed.gov).
- ◆ Submit a copy of your signed 2008 U.S. Income Tax Return (1040, 1040NR, 1040NR-EZ, or Form 8843) along with this form. **U.S. Internal Revenue Service guidelines require all international students to file a tax return.** If you are not familiar with this requirement and you need additional information or copies of the tax returns, contact the University of Michigan International Center at 734-764-9310. Because this is a federal requirement, your application will not be considered until a copy of your tax return is submitted. If you did not reside in the United States during 2008, please submit a statement to that effect.
- ◆ Complete a Household Information Questionnaire and a Dependent Child(ren) Questionnaire, available from OFA or on the web at [www.finaid.umich.edu/types\\_of\\_financial\\_aid/child.asp](http://www.finaid.umich.edu/types_of_financial_aid/child.asp).
- ◆ After you have completed these forms and the Child Care Subsidy application, submit them with a signed copy of your 2008 tax return to the Office of Financial Aid at the address above.
